TIME OF SUPPLY

Goods for private or non-business use

3. Where the services referred to in subparagraph 5(3) of the First Schedule of the Act are supplied over a period of time, the services shall be treated as being supplied on the last day of the supplier's taxable period, or of each such taxable period, in which the goods are used or made available for use.
