

Accounting for tax

32. (1) Tax shall be accounted for and paid to the Director General by the due date determined for the taxable period in which payment or other consideration for the supply is received.

(2) Input tax may be credited either in a taxable period in which payment is made or other consideration is given for a supply or in such later period as may be approved or directed by the Director General under section 38 of the Act.
