

Manner of making a declaration

62. (1) Every declaration required to be furnished by a person other than a taxable person to the Director General under section 42 of the Act shall be in Form GST-04.

(2) All particulars as required in Form GST-04 shall be furnished by a person other than a taxable person and shall contain a certification that such declaration is true and complete.
