TOURIST REFUND SCHEME

Interpretation

79. In this Part—

“approved refund agent” means any agent appointed by the Minister to refund tax to a tourist under the Tourist Refund Scheme (which is referred to in this Part as “TRS”);

“approved outlet” means any business establishment operated by a registered person and appointed by the approved refund agent for the purpose of the TRS.
